

SENIOR CERTIFICATE COURSE IN SUGARCANE AGRICULTURE

03 JUNE – 05 JULY 2024: COURSE DETAILS AND APPLICATION FORM

This five week course in sugarcane agriculture is held at the Kwa-Shukela building of the South African Sugar Association (SASA) offices in Mount Edgecombe. The course is held once or twice each year, usually in February and June, numbers permitting.

Entry Requirements

The general entry requirement is an undergraduate degree or diploma, preferably in agriculture or the sciences.

A student who has a matric (Grade 12) and has passed the Junior Certificate Course with a Merit Pass (65% and above) will also be entitled to enroll.

A student who has a matric (Grade 12) certificate will be considered, depending on the outcome of an assessment and interview process.

The course and assessments are conducted in English and therefore requires that applicants be able to read, write and understand English.

This cost includes stationery (pen, pencil, ruler, eraser and calculator), course notes, SASRI Information Sheets, manuals, teas and excursion costs. Applicants should bring their own notebooks or writing pads. **This cost includes TUITION only – no meals are included.**

Foreign students must arrange their own transport from their point of arrival in South Africa to their place of accommodation. Neither SASRI nor the STC provides a shuttle service. SASRI does, however, provide a daily shuttle service between STC residences and the course venue.

There are canteen facilities at the course venue where light lunches, snacks and cold drinks are available.

Course Structure and Content

The duration of the course is five weeks and comprises both lectures and practicals. Each day commences at 08:00 and finishes at approximately 15:30. There are 10 minute intervals between lectures and a mid-morning tea break of 20 minutes. Tea and coffee is provided. The lunch break is from 13:00-13:40.

 - Botany: structure, propagation and physiology of cane plants
 - Agronomic characteristics
 - Identification of varieties
 - Choice of varieties
- 3. Diseases and Pests**
 - Sugarcane diseases

Course Assessment

Tests are written after completion of each subject. The duration of tests are approximately two hours. Certificates are awarded in three classes namely:
